Ms. Thompson added that the plat should reference whether or not the Tree Farm covenants would be abolished or carried forward. Mr. Weiss requested that the petitioner step forward. Krista Pope was present and explained that her father owned the surrounding property and had given her the additional acreage to allow for the construction of a pond. She added that the replat was necessary in order to combine the property. There were no questions for Ms. Pope.

Mr. Graft made a motion to approve the petition as presented and with the two conditions suggested by staff. Mr. Langeloh gave the second, and the members voted unanimously to carry the motion.
