
WCCC Annual Program Summary FY 2018-19

Residential Work Release






WCWR had 192 intakes during the 2018-19 year. 76% of those have come directly from WCJ. The total annual ADP for the year was 77. Female annual ADP was 14, and male was 63. Seven individuals utilized the Transitional Housing Program.

Of the 192 intakes, 53 were misdemeanors with 87% being A Misdemeanors; this compares to 88% last year.

The percentage of misdemeanors and felony intakes from last year to this were identical at at 29% and 71%, respectively.

The goal of successful completion or modification of sentence is often met upon exit, however, terminations occur for various reaons. During 2018-19 there were 192 exits.

Veterans Treatment Court

Veterans Treatment Court team screened 11 people this year finding 7 eligible for services.

Nine program completions; three terminations.


Seven veterans transferred in from other counties for court participation, while two transferred out.

Community Service Hours




The community service program continues to provide a way for offenders to give back to the community through a structured program. Hours are tracked as provided through Whitley and surrounding counties as ordered by the Courts.

A total of 15,440 hours provided this year totalled \$111,937 in labor to non-profit organizations with \$71,716 in labor benefiting Whitley County non-profits.


Forensic Diversion

The FD program has continued to service individuals in Whitley County as well as surrounding counties. The ADP spanned 237 to 260 throughout the year. This year has seen a fairly even split between individuals with misdemeanor and felony offenses. A steady increase is noted throughout the year of pretrial referrals for those with misdemeanor offenses.

Home Detention




HD had 75 intakes this year with 56 (75%) being sentenced in Whitley County. 17 (23%) were courtesy supervision from other counties; this a **10% increase** over last year. Whitley County cases that transfer out of county for supervision decreased from 32% to 26% this year.


22 (30%) of HD participants were convicted with a primary misdemeanor charge while 52 (70%) were had a primary felony conviction; these are the same percentages as last year.

87% (63) of adult participants and 5/7 juveniles successfully completed the home detention program. The adult success rate by percent is identical to last year.

Employment Services Program

The employment services program (ESP) worked with 114 participants in 2018-19. 93% (106) were successfully employed within 30 days of completing the employment program.
