## FORENSIC DIVERSION

FD received **117 new referrals** this quarter, a **13% increase** from Q2. **45%** of new referrals fall into the poverty level (down 6% from Q2) with **21%** reporting unemployed status (down 5% from Q2). **81%** report at least a HS/GED education.



## MRT / DV-MRT

#### REFERRALS:

>>> Overall, referrals to the MRT program have decreased this quarter.

>>> MRT classes had a total of nine (9) new referrals this quarter:

>>>> 2 from RWR; 3 from Prob; 2 from WSCADP; 1 from HD; 1 from VTC

>>> DV-MRT received four (4) new referrals:

>>>> 3 from Court and 1 through a DPA

>>> Nine (9) individuals successfully completed MRT (6 RWR; 3 Probation)

>>> Two (2) individuals were terminated from MRT this quarter (1 RWR & 1 Probation)

>>> Five (5) individuals successfully completed DVMRT

>>>> 3 RWR; 1 Probation; 1 VTC


>>> One (1) individual was terminated from DVMRT (Court referral)

### VETERAN'S TREATMENT COURT




## EMPLOYMENT SER VICES
