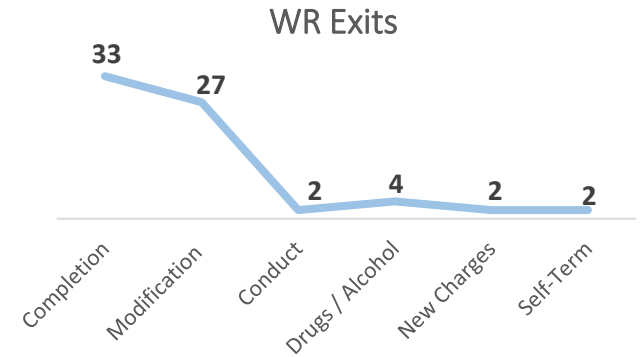
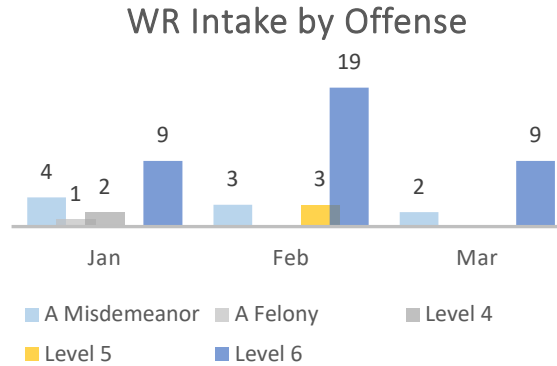

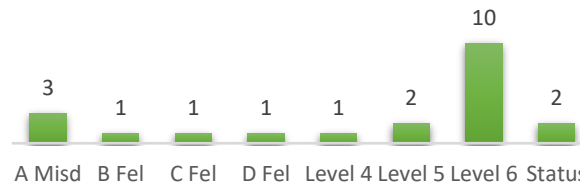
There were a total of 52 intakes and 73 exits from work release this quarter. This is a decrease of intakes by 4% and an increase of exits by 37% over the Q1 2019.



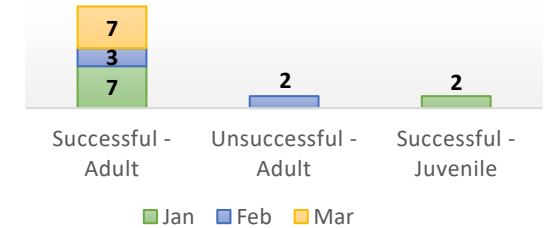

All program participants maintained eligibility this quarter and one veteran successfully completed the program bringing the program graduate total to twelve.

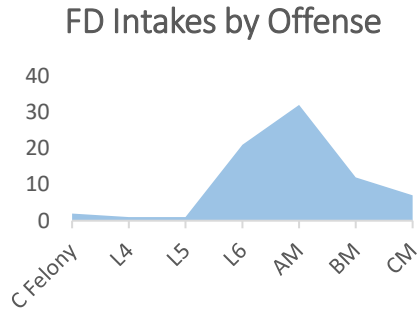
Collaboration within the VTC team resulted in the admittance into the program of a Veteran of the Bosnian Army.

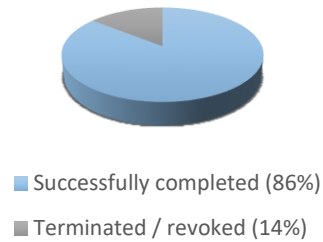
## FORENSIC DIVERSION

37% of new referrals fall into the individual poverty level with 24% unemployed.



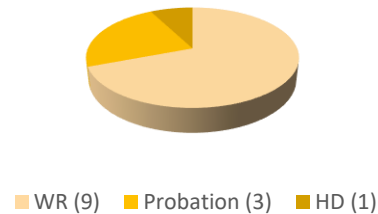
FD Exit Status



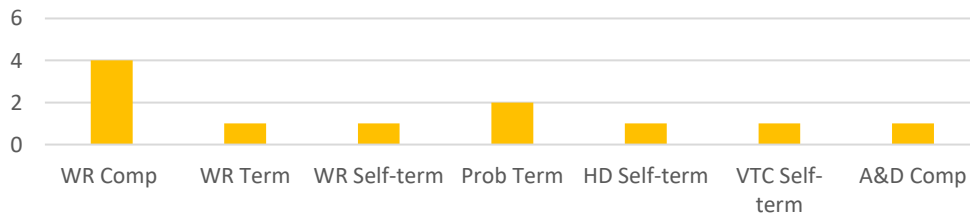

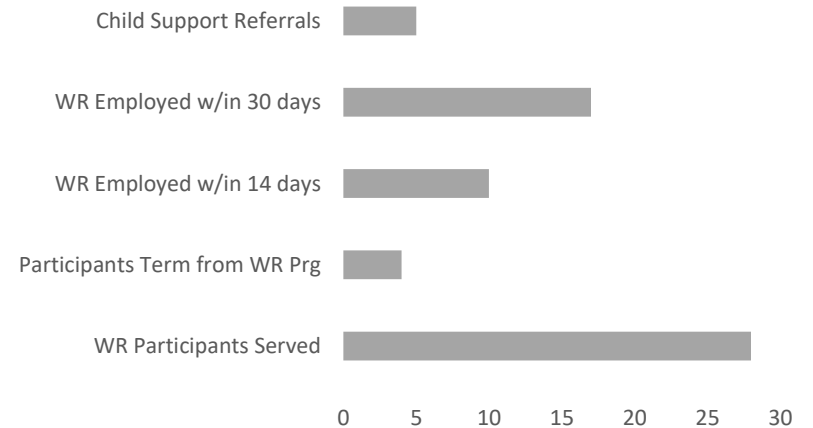

Employment Coordinator worked with 14 companies to employ participants.

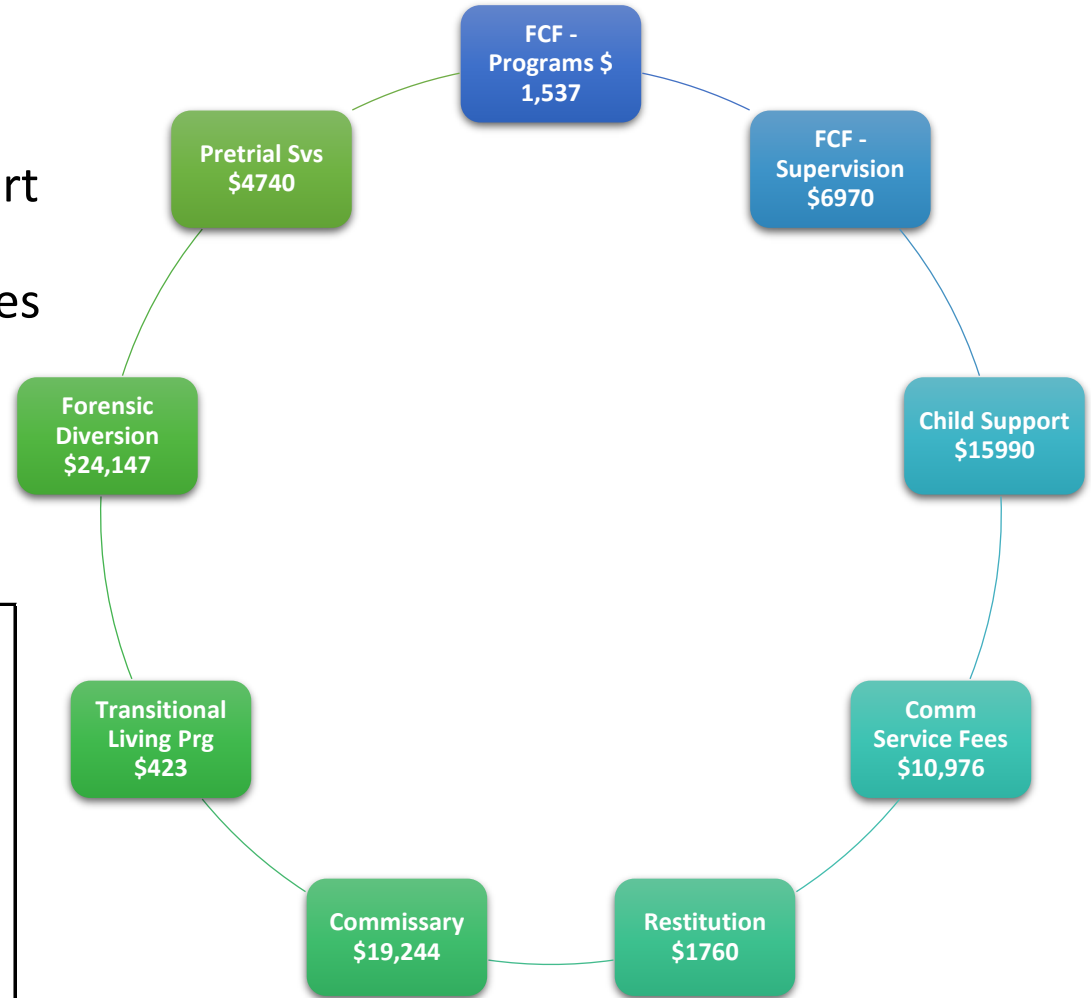
