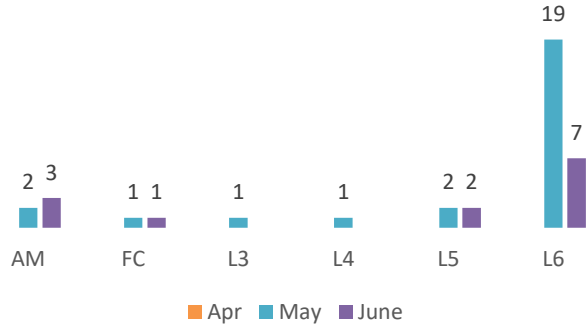

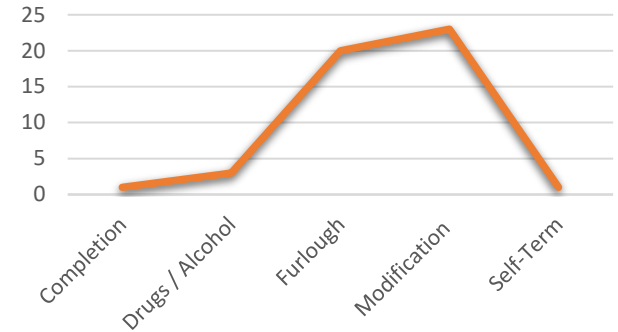

WR Exits

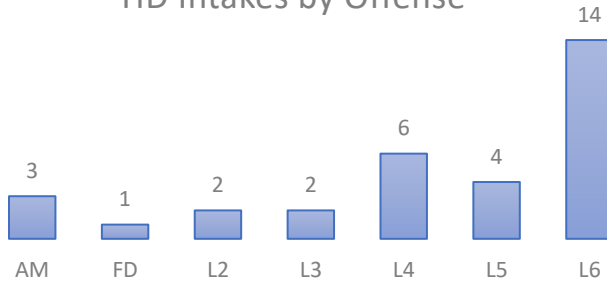


Beginning the last week of March through the first of April, the WR facility transitioned its participants to alternative forms of supervision. While these participants were out of the facility, WR and HD case managers continued to provide routine supervision including providing community resources for virtual AA/NA Zoom meetings, Carey Guides were provided, and IRAS assessments were completed to maintain DOC compliance. In addition, 149 reviews of the Offender Management System were completed for those on furlough to ensure no new criminal activity had taken place. In total, over 1445 phone calls were made by the team to participants, during April and May, to provide consistent supervision and services to the WR participants while they were out of the facility.

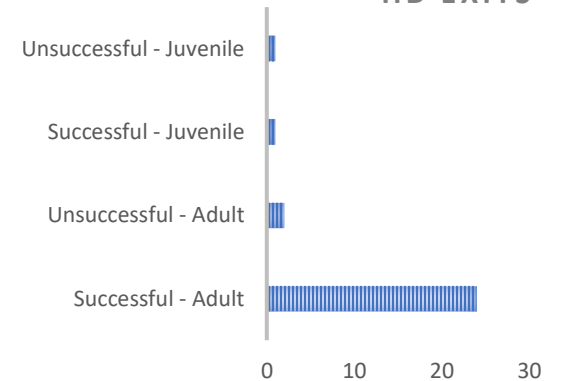

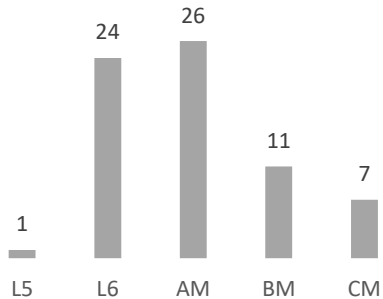


FORENSIC DIVERSION

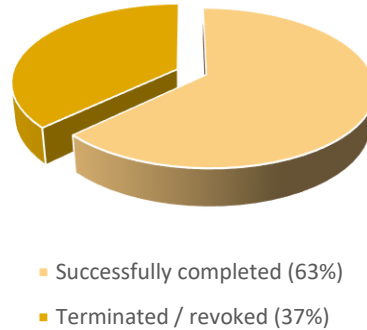
FD averaged 187 participants per month this quarter, down from 199, with 69 new referrals.

42% of new referrals fall into the individual poverty level with **34%** unemployed.

COMMUNITY SERVICE

Due to COVID-19 CS was shut down for 3 weeks this quarter and due to limitations throughout the state there was an overall reduction in CS numbers by 50% this quarter. The CS supervisor now schedules 4 individuals daily to serve on the Work Crew.

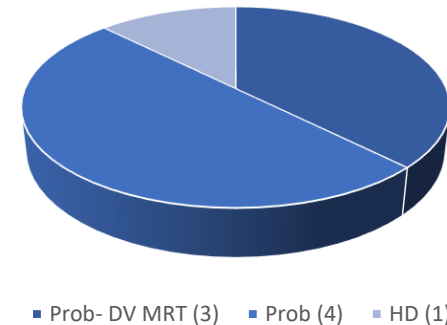
There were no other terminations from the MRT programs.

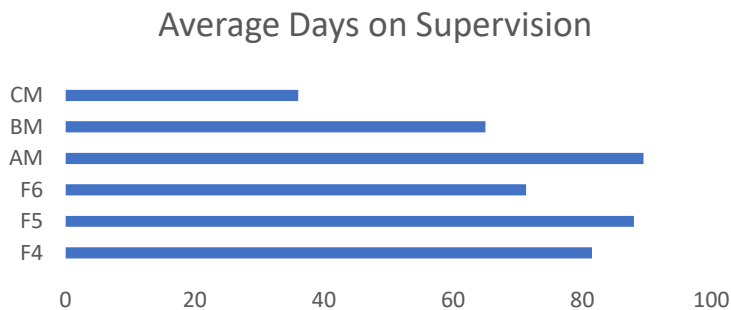

PRETRIAL SERVICES

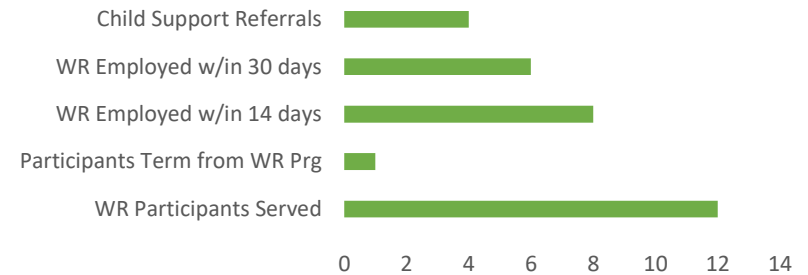
Misdemeanor supervision time has decreased this quarter while felony supervision has increased compared to Q1.
